Breakfast with homemade and typical local products. Guided walks and hikes from the house to discover the most interesting sites of the Park, such as the Infernaccio Gorge and the Pilate Lake; activities in the kitchen garden, local crafts workshops, local food and wine tastings are organized throughout the year.
